**WAIVER AND RELEASE OF LIABILITY AND INDEMNITY AGREEMENT**

Upon signing this agreement, you agree that your child's participation in, attendance of, and/or presences on the premises of the 2017 Community Building Soccer Camp (Camp) is at your own risk and that you assume the risk of any and all injury and/or damage your child might sustain, regardless of whether your child is a participant, spectator, or otherwise. Your assumption of risk includes but is not limited to the use of any sports or other equipment (mechanical or otherwise) and accessing Camp premises. You further agree to assume the risk of your child's participation in or presence at any sporting event, practice, activity, class, program, instruction or Camp sponsored event. You agree that your child is voluntarily participating in camp activities and assume all risk, known and unknown, associated with the same. You agree on behalf of yourself (and your spouse, children personal representatives, heirs, executors, administrators, agents, and assigns) to forever release and discharge the Camp, their owners, employees, agents, representatives, affiliates, successors, and assigns from any and all claims or causes of action (known or unknown) arising out of the negligence of the Camp, whether active or passive, or that of any of its affiliates, employees, agents representatives, successors, and assigns.

This waiver and release of liability includes, without limitation, injuries which may occur as a result of (a) your child's use of any equipment or facilities which may malfunction or break, (b) Camp's improper maintenance of any exercise equipment or facilities, (c) Camp's negligent instruction or supervision, including personal training, strength training, refereeing and coaching, (d) your child's slipping or tripping and falling while on Camp premises, including Camp's negligent inspection or maintenance of such premises, (e) your child sustaining personal injuries as a result of the dangerous condition of property on which your child is present in relation to any Camp function, and (f) your child sustaining a concussion or head injury while on Camp premises and/or using Camp equipment and/or participating as a player or spectator of the Camp.

By executing this Agreement, you hereby agree to indemnify and hold harmless the Camp from any loss, liability, damage, or cost Camp may incur due to your child's presence at any Camp premises or facility. You further expressly agree that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the law of Washington State and that if any portion of this agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. This release is not intended as an attempted release of claims of gross negligence or intentional acts. You acknowledge that the Camp performs a service to participants and is not in the business of selling, leasing, or otherwise placing into the stream of commerce exercise or sports equipment, or other such products, and the use of any such items is incidental to the service provided by the Camp.

**YOU ACKNOWLEDGE THAT YOU HAVE CAREFULLY READ THIS WAIVER AND RELEASE AND FULLY UNDERSTAND THAT IT IS A RELEASE OF LIABILITY, AND EXPRESS ASSUMPTION OF RISK AND INDEMNITY AGREEMENT. YOU ARE AWARE AND AGREE THAT BY EXECUTING THIS WAIVER AND RELEASE, YOU ARE GIVING UP YOUR RIGHT TO BRING A LEGAL ACTION OR ASSERT A CLAIM AGAINST THE CAMP FOR NEGLIGENCE OR ANY DEFECTIVE PRODUCT ON THEIR PREMISES. YOU VOLUNTARILY SIGNED THE WAIVER AND RELEASE AND FURTHER AGREE THAT NO OTHER OTHER AGREEMENT (ORAL REPRESENTATIONS, STATEMENTS OR INDUCEMENT) HAS BEEN MADE.**
